Allamakee County Agricultural Society - Horse Arena Rental Agreement

The Outdoor Horse Area and Indoor Show Ring are both available for leisure horse use throughout the year. This contract outlines the details of use.

The Outdoor Arena is available year-round when the weather and arena is fit. From April 15-Aug 1, the outdoor arena is only available Friday afternoon through Monday evening.

The Indoor Show Ring is available from Oct 15-April 15. There may be some date exceptions for other events.

The annual fee for use of the outdoor Horse arena is \$100/household.

The annual fee for the outdoor Horse arena and Indoor Show Ring is \$250/household.

Annual payments are due by November 1 of each year.

- 1. The Allamakee County Agricultural Society is not responsible for accidents.
- 2. The Allamakee County Agricultural Society is not responsible for lost or stolen items.
- 3. All riders under 18 are required to wear helmets. Helmets are strongly encouraged for all riders.
- 4. From April 15-Aug 1, leisure riding schedule will work around the 4-H Program schedule. In case of inclement weather, 4-H has the option of rescheduling at their convenience. You will be notified by text message of availability.
- 5. All riders, both adults and children, must have a signed usage agreement and paid the annual fee.
- 6. Night Riding in the Outdoor Arena is not allowed.
- 7. Please pick up after yourselves. Trash Cans are not provided, please plan accordingly.
- 8. You are required to clean up after your horses. No tools will be provided. Please plan accordingly.
- 9. Use of the Show Barn restrooms is allowed. Please be respectful. The Office and Bathroom doors are to remain propped open.
- 10. Failure to follow the rules will result in loss of use, with no refund.

The main entrance to the building will have a Passcode. The passcode will be made available to the contact person on each signed contract. We will periodically change the passcode to maintain security. The passcode is not to be shared with anyone. Surveillance cameras are located inside and outside of the Show Barn. Please be respectful of the facility, so that this option can continue to be offered.

There may be times when the indoor arena is being used for other events. In this case, you will receive a group text message letting you know. By signing this contract, you agree to receive group text messages from a member of the Allamakee County Fairboard.
