The Details

FAIR HOURS: Our gates are open from 6AM until 12AM every day. The pavilion will be open to the public from 11am-8pm Thursday through Friday and 9am-3pm on Saturday. Outside of exhibitor hours, the pavilion will be locked and closed to the public.

SET UP: Outdoor exhibitors are welcome to begin setting up their exhibits beginning **Tuesday, July 14th at 8AM**. Set up will continue on Wednesday, July 15 until 1PM. Pavilion exhibitors may begin set up **Thursday, July 16th at 8AM**. If other accommodations need to be made for set up, please let us know.

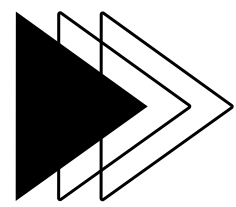

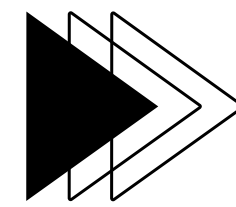
NO STAPLES, TAPE, NAILS OF ANY KIND ARE ALLOWED IN THE PAVILION.

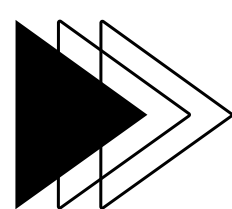
