Dear Fair Supporter:

As a Fair Board, we've been working extremely hard to navigate the best way to make the 2020 Allamakee County Fair a reality! With the most recent proclamation by Governor Reynolds allowing outdoor gatherings, we feel we can safely move forward with plans for the Allamakee County Fair!



By following guidelines recommended by the CDC and State Health Department, we are hopeful and optimistic that we can still provide the traditional and affordable entertainment that the fair is known for.

We have modified the fair schedule to help limit capacity. We feel we can safely offer many outdoor events, with a focus on youth exhibits, livestock projects, and grandstand entertainment. The Extension Staff have modified the 4-H/FFA schedule of events and activities to help limit capacity and adhere with regulations, both from health officials and Iowa State University Extension.

We plan to sell grandstand tickets until 50% capacity is reached. As restrictions change, we will comply and make adjustments accordingly.

We will start things off Thursday, July 9 with free outdoor entertainment at the fairgrounds. Here we will recognize our 2020 Fair Royalty Team and enjoy live music by **The Caminos**. Our Free Entertainment will also feature **Magic by Waukon Native, Jonathan May!** He is a Full-Time Magician and Comedian based out of Central Iowa. We will also feature Balloon Twisting and Caricatures – Free to All Fair-goers!

In addition, we will host local contests and feature local talent of all ages. More details will follow online, on Facebook, and in The Standard.

Grandstand entertainment will feature our **Local Truck and Tractor Pull on July 10, ATV/UTV Event on July 11, as well as the Tough Truck Competition on July 12.** We plan to have several food vendors available.
